HOW TO ORDER

There are four steps to ordering on SCMC:

- I. The DoE customer contacts the appropriate CTG Federal team member to finalize their Bill of Materials.
- 2. The CTG Federal team member references the applicable SCMC terms and conditions on the estimate.
- 3. The DoE customer provides that information to their contracting officer to utilize the SCMC contract for that procurement to obtain applicable pricing discounts and delivery terms.
- 4. The procurement officer reaches out to the CTG Federal operations team to execute a Purchase Order for that Bill of Materials. All orders should be delivered to operations@ctgfederal.com. In the order, please reference SCMC Agreement Under Contract Number WSI808I4 Network Appliance Storage Equipment and Services and reference the CTG Quote Number. Please also list the technical point of contact (name, phone number, and email). Finally, please reference where to deliver the invoice.
